Validity Conditions

During the validity period of this Certificate;

The Certificate Holder must proof that he/she has frequently performed as Visual Welding Inspector VT-w, level 2, according to the ISO 9712:2012. In compliance with the standard ISO 9712:2012 par. 9.4.1., this certificate becomes invalid in case the Holder has not performed as Visual Welding Inspector VT-w, Level 1/2 for either a continuous period in excess of one year or two or more periods for a total time exceeding 2 years.

DNV Business Assurance B.V. can require from both Certificate Holder and Employer a written statement. In case of non-compliance or no sufficient reaction within the given time frame, DNV Business Assurance B.V. will declare the Certificate invalid.

- 2. The Certificate Holder must update and refresh his knowledge and skills on a yearly basis. Therefore, as a minimum, he shall;
 - Pro-actively participate in relevant technical congresses and forums,
 - Participate in refreshment courses as assigned by the Committee of Experts,
 - Keep and maintain a log book with registrations of all inspections, during the validity period of the Certificate, to be presented to DNV Business Assurance B.V. on request.
- 3. The certificate Holder must be able to present yearly, a written declaration, stating his conformity with the requirements as stipulated in the ISO 9712:2012 with respect to the required visual abilities for Visual Inspectors.
- 4. Renewal

Upon expiry of the first period of validity and every ten years thereafter, certification may be renewed by the certification body for a new period of five years on production of:

- Verifiable documentary evidence of a satisfactory visual acuity examination taken within the preceding 12 months;
- Verifiable documentary evidence of continued satisfactory work activity without significant interruption in the method and sector for which certificate renewal is sought. If the criterion for renewal are not met, the individual shall follow the same rules as for recertification. It is the responsibility of the certificate holder to initiate the procedure required for renewal.
- Recertification

Upon completion of each second period of validity (every ten years), the certified individual may be recertified by the certification body for a new period of five years, on the basis of the following requirements:

- Meet the criteria for renewal
- Successfully complete a practical examination organized to a simplified procedure which demonstrates continued competence
- within the scope defined on the certificate.
